NO: CON-3/PAP/65/10 // In supersession of this Department's earlier Notifications of even number Dated: 09/12/2019 and 20/06/2023 and in exercise of the power conferred under Section 2 of the Bengal Eastern Frontier Regulation 1873 and in the interest of Public, the Governor of Nagaland is pleased to extend the Inner Line to cover the Districts of Chumoukedima, Niuland and Dimapur.

- Inner Line Permit (ILP) will be implemented in the District of Chumoukedima and Niuland with immediate effect.
- 2. ILP in Dimapur District shall be implemented under the following categories.

- 3. The Deputy Commissioner Dimapur will set-up an administrative cell for identification and enumeration of individuals belonging to Category I & II. This exercise may be completed at an early date. During the intervening period, people under Category III shall apply for ILP.
- 4. The Deputy Commissioner, Dimapur shall issue 30 days permit at nominal rate to daily wage Labourers coming from the neighbouring States.
- 5. Any person from other States passing through the Districts of Dimapur, Chumoukedima and Niuland as a transit passenger/traveler and having a valid ticket will not be required to obtain an Inner Line Permit.
- 6. This Notification is issued in pursuance of Cabinet decision Vide No:CAB-1/14/2023 Dated: 12/09/2024.
