// Whereas in pursuance of Cabinet decision Vide: No:CAB-1/14/2023/ Dated: 12/09/2024, with regard to eligibility criteria of being an Indigenous Inhabitant of the State of Nagaland and issuance of Indigenous Inhabitant Certificate, an Enumeration Exercise is to be conducted of the people and their direct descendants from Garo, Kuki, Kachari and Mikir (Karbi) settled in the State of Nagaland prior to 1<sup>st</sup> December, 1963 so as to determine their eligibility for issuance of IIC/PRC. The enumeration of Nepali/Gorkhas who are permanently settled in Nagaland prior to 31<sup>st</sup> December 1940 and their direct descendants will also be conducted simultaneously.

2. The Enumeration shall be conducted by the concerned Deputy Commissioners at the village/town level and may be done in the proforma prescribed at Annexure – I (enclosed). The Enumeration Sheet being forwarded for draft publication must be countersigned by the following authorities, viz:
  - i. Village Council Chairman/ Town Council Chairman/Municipal Council Chairman, as applicable.
  - ii. The Concerned Village GB.
  - iii. The Area Administrative Officer (EAC/ SDO(C) / ADC)
  - iv. The Chairman/ President/ Representative of the Garo, Kachari, Kuki, Mikir (Karbi), Nepali/Gorkhas as applicable.
  - v. The Deputy Commissioner of the District.
3. The Copies of all the Final Enumeration Sheets shall be submitted to the Home Department through the Commissioner, Nagaland, which shall be placed before the Cabinet for decision.
4. The modalities for the process of Enumeration may be worked out by the Commissioner, Nagaland.
